the motion.

b. Ordinance #790 – 2019 Real Estate Tax Ordinance:

Motion: To enact Ordinance #790, the 2019 Real Estate Tax Ordinance, to set the real estate tax

rate pursuant to Section §1310.1 of the Borough Code for the Year 2019 at the following rates: Real Estate Tax = 3.35 mills; Public Library Tax = .06 mills. Motion by Tom Miller, second by Don Barry. Motion passed by a 6-1 vote with Jane Quairoli voting

against the motion.

c. Ordinance #791 – Amend Chapter 305 (Solid Waste) Section 305-15 (Alternatives for Collection from Apartments):

Motion: To enact Ordinance #791, an ordinance amending the minimum number of per property

apartments required before being eligible to contract refuse & recycling collection services from a private hauler. Motion by Jane Quairoli, second by Don Barry. Motion

passed.

d. Financial Security Release Request – Palmyra Middle School Addition Project:

Motion: To approve the recommendation made by the Borough Engineer to authorize the

Borough Treasurer to release the remaining \$13,300.00 being held as financial security from the Palmyra Area School District for proper completion of the Middle School Addition Project. Motion by Jane Quairoli, second by Don Barry. Motion passed.

#### Reports

- a. President's Report: President Shearer wished everyone a Merry Christmas and Happy New Year and thanked the Police Department and Public Works Department for their assistance with the year's PAHA events.
- b. Library Report: Councilor Quairoli commented that there was no meeting in December and wished everyone a Happy Holiday.
- c. Police Department: Mayor Carpenter reported that this is the last meeting for Police Chief Stanley Jasinski as he will be retiring on December 30<sup>th</sup>. Council thanked Chief Jasinski for his 40 years of service to the Borough of Palmyra.

Motion: To authorize Resolution 2018-30 authorizing the disposal of Borough owned personal

property to present Chief Jasinski with his service pistol for his retirement. Motion by

Jane Quairoli, second by Beth Shearer. Motion passed.

- d. Solicitor's Report: There was nothing to report.
- e. Zoning Hearing Board: No Hearings were conducted in December
- f. Borough Manager's Report:
  - 1. 300 Block E. Cherry St / 100 Block S. Grant St Stormwater & Road Restoration Project: Mr. Powl reported that the contractor has done what they can for this year and will return in Spring to apply asphalt wearing course and complete trench restoration. The contractor has been asked to

move his equipment to the east side of S. Grant Street next to the new detention basin so that S. Grant Street can be reopened to traffic.

- 2. New Public Works Garage Building Project: Mr. Powl explained that the Public Works crew has connected the sewer lateral and water supply lateral to the new building. This enabled the site around the building to be backfilled and graded by our staff so that stone could be placed around the building to allow access to the building by vehicles. He also mentioned that the plan calls for construction of a small storm water basin on site, but at the Borough's request, the contractor will wait until Spring to install this system to eliminate muddy conditions over the winter.
- 3. Southeast Park Sinkhole Repair: Mr. Powl reported that Custer Excavating will be waiting until after the new year to begin this project since he needs to order larger sized stone from the quarry and they often do not have the larger stone in stock every day. He will need to create a stockpile prior to commencing with the excavation and repair.

## Other Business

• Mayor Carpenter asked Council to consider having the banners removed from the Borough streets as they are weathered and torn. Council agreed and asked Mr. Powl to have the Public Works crew remove the banners when they take down the holiday lights.

• Len Chimel, 1 N. Clearview Drive, Palmyra, asked for a clarification on Ordinance #791, and a when it would be in effect.
