Borough Council President Jane Quairoli called the meeting to order at 7:00 PM in Council Chambers of the Palmyra Municipal Center, located at 325 S. - a. President's Report: President Quairoli announced that it has been a pleasure to serve the community and thanked the rest of Council for working with her.
- b. Financial Statement: Council review and discussed the financial statement as of November 30, 2015.

- d. Library Board Report: Councilor Craig provided a copy of the December 2015 report.
- e. Police/Mayor's Report: Mayor Carpenter provided a copy of the November 2015 Monthly Police Report. He also announced that he has received donations for two police bicycles and will reinstate the bicycle patrols in town.
 - Ms. Pera informed Council that the oral exams are completed. Two candidates did not pass. The top five applications will be forwarded to Chief Jasinski for background investigations to be completed. Once they are finished, the Civil Service Commission will certify the top three names for consideration.
- f. Planning Commission: Did not meet in December. The next meeting is scheduled for Wednesday, January 6, 2016 beginning at 7:00 PM.
- g. Recreation Commission Report: Councilor Hennessy provided a copy of the December report.
- h. Solicitor's Report: There was no report.
- i. Zoning Hearing Board: No hearings were conducted in December.

j. Borough Manager's Report:

- 1. New Municipal Building Project Status Update: Mr. Powl informed Council that he was under the impression the HVAC issues were wrapping up, but was informed that there are several outstanding items that will need to be resolved. He also mentioned that Beers & Hoffman is working with the contractor for the purpose of releasing some of the retainage. The floor contractor is expected to schedule some time in the next several weeks to re-finish the stained concrete floors.
- 2. Mr. Powl informed Council that the toolbox door on Vehicle #7 was repaired as directed by Council at the 12/8/15 Workshop meeting.
- 3. Mr. Powl provided an update on the PA American Water Co. Railroad Street Water Main Replacement Project.
- 4. Mr. Powl advised Council that they need to appoint a Vacancy Board Chairman. He also informed Council that Jay Armold's seat on the Municipal Authority is expiring. Mayor Carpenter volunteered to contact Mr. Armold to inquire of his interest to continue serving in the position.

- Councilor Templin inquired about the pricing for the Fireman's Park Pavers and Ms. Pera explained that she is still waiting for the updated pricing information from Long's Nursery.
